## III. ANNUAL MEMBER SURVEY (Item 3)

The committee received a presentation from Mr. Buffalo covering the results of the 2023 Member Survey and learned that overall satisfaction with CalSTRS decreased in 2023. The committee received information about the factors driving the decrease in satisfaction and trust with CalSTRS, including decreased member confidence in meeting financial needs in retirement due to increased economic uncertainty and inflationary pressures. The committee discussed the historical sensitivity of survey results to current economic conditions and what specific economic conditions impact CalSTRS members the most. The committee learned that older members reported higher levels of satisfaction and engagement than younger members and members who interacted with CalSTRS reported higher levels of satisfaction and engagement than those who did not interact with CalSTRS. The committee expressed concern about survey results showing that half of the responding members felt that CalSTRS does not listen to its members. The committee heard from Mr. Perez about what specific concerns members may have, how to get more information about these concerns, and address this issue going forward. The committee discussed whether polling methods and question phrasing may have impacted survey results.

Mr. Ruffino and Ms. Miller left the dais at 3:30 p.m.

Pursuant to item 3, the committee requested a future educational item about the different business areas of Benefits & Services, how and when CalSTRS interacts with members, how and when CalSTRS gathers feedback from members, and detailed statistics and response data related to member feedback.
