Dear Senator Skinner:

Pursuant to section 22955.5(b) of the Education Code, the California State Teachers' Retirement System (CalSTRS) submits a report each year which includes the amount of creditable compensation for the fiscal year that ended on the immediately preceding June 30. As required, the report is also being submitted to the Director of Finance and the Legislative Analyst.

The creditable compensation reported to CalSTRS in the fiscal year ended June 30, 2022¹, is \$36,960,824,188.71 (see Exhibit A). CalSTRS will notify the committee of any revision on the amount stated above on or before April 15, 2023.

Of the amount of creditable compensation earned and reported for fiscal year 2021-22, \$2,766,826,672.38 (see Exhibit B) is from community colleges.
