

1. Chief Investment Officer Report




CHIEF INVESTMENT OFFICER REPORT

An understanding of global market performance in the current fiscal year and recent 3-year period is helpful context when reviewing semi-annual reports for each asset class. Since CalSTRS has a 30-year investment horizon it is helpful to look at these semi-annual snapshots over multiple time periods to get a sense of the changes. Global Equity markets provided strong returns the past 3 years, especially the past fiscal year.




U.S. Treasury Yield Curve

FY 2023-24





Asset Allocation

During the May 2024 meeting, the Investment Committee adopted new interim asset allocation targets effective July 1, 2024. These targets included a reduction in Public Equity and an increase in Fixed Income. The Investment Committee finished its every-four-years Asset-Liability Management Study in 2023 when it adopted long-term asset allocation targets.








Non-U.S. Top 10 Net Exposure as of June 30, 2024




Non-U.S. Net Currency Value vs Total as of June 30, 2024

Internal Marketing Firms*
