Senate Bill 765

- Effective July 1, 2024 June 30, 2026
- Increased annual earnings limit
- Updated exemption requirements





Annual Limit Increase

SB765 temporarily increases the postretirement compensation annual limit from 50% to 70% of the median final compensation of all members who retired from service during the fiscal year ending the previous calendar year.

2024-25 Annual Limit \$74,733 2023-24 Annual Limit \$50,655

Maintained Exemption Requirements

- CalSTRS must receive form prior to the retired member performing any activities for this requested exemption position.
- Retiree must be normal retirement age when the compensation is earned (age 60 for 2% at 60; age 62 for 2% at 62).
- Retiree cannot have received any financial inducement to retire.
- The appointment must be necessary to fill a critically needed position.
- The retiree's termination is not the basis for the critical need.

New exemption requirements

- Employer did not have a reduction-in-force layoff pursuant to Section 45117, 44955, 44955.5, or pursuant to any other similar state law authorizing the termination of its employees, within the prior 18 months.
- The employer shall provide a written copy of the completed documentation that substantiates the need for the exemption to the exclusive representatives of employees prior to the member's performance of retired member activities.

All exemptions submitted on or after July 1, 2024 must be on new exemption form, revised July, 2024.
